The Government of Lebanon has received a donation from the Italian Government for Recovery, Reconstruction and Reform and intends to apply part of the funds to cover eligible payments under the contract for the REHABILITATION AND COMPLEMENTARY WORKS FOR DANNIYEH WATER PROJECT (PHASE I – PACKAGE 1)

The Council for Development and Reconstruction (CDR) acting as executing agency for and on behalf of the Government of Lebanon, and as Employer under the Contract invites sealed bids from eligible bidders for the REHABILITATION AND COMPLEMENTARY WORKS FOR DANNIYEH WATER PROJECT (PHASE I – PACKAGE 1), the project consists of rehabilitation of existing pipes, laying of new pipes, rehabilitation of existing water tanks and construction of a spring intake in lot 3 (Villages of Beyt Hawiq, Hawara, Beyt el Faqs, Kfarbebnine, Jouret el Mrah, Hazmiyeh, Sfeyreh, Mrah el Sfeyreh, Maqtouaa, Ayn el Tineh, Qarsita and Nemrine) and lot 5 (Villages of Bakhoun, Bqarsouna, Beyt Moumne, Beyt Jida, Haql el Aazimeh, Sartouka, Qattine, Aasoun and Qatrane) of Dannieh region.

Eligible bidders are Contractors bidding jointly or separately and meeting the requirements stipulated in the relevant Tender Document.

Bidders will be post-qualified after submitting all required and necessary information stated in the Tender Documents, and shall satisfy mainly the following:

- The minimum average annual turnover (in construction works) over the last three years shall be Three Million Euros (3,000,000 Euros).
- General experience of a minimum of ten years in water and wastewater projects.
- Particular experience within the past ten years as prime Contractor in the construction of water supply systems for a total value of not less than 5 Million Euros; among which one project for a total value of not less than 3 Million Euros

A complete set of Bidding Documents in English (and each additional copy) may be purchased at Council for Development and Reconstruction - Tallet El Serail - Beirut, Lebanon, for a non-refundable fee of One Thousand US Dollars (1,000 US\$), for each set starting from **Monday, November 7th, 2016**. Bids shall be valid for a period of One Hundred and Eighty (180) days after Bid opening and must be accompanied by a bid security of 150.000€ (One Hundred Fifty Thousands EUROS) and shall be delivered to the address below on or before **Wednesday, January 11th, 2017**, at which time they will be opened in the presence of the bidders who wish to attend.
