1	We would like to know if the payments of the above mentioned project are fresh money	In accordance with document “ Volume 2, Section 2: Special Conditions ” of the tender dossier, para. 44.1 “General principles for payments ” stating “ <i>An amount not exceeding 50% of the total amount of the contract shall be paid as local transfer from a Lebanese bank account to the Lebanese bank account mentioned in the financial identification form completed by the contractor. This modality of execution will be used to execute the payments of the first instalments up to the first 50% of the total amount of the contract.</i> ”, at least 50% of the payments will be done using the so called “fresh money” currency, but this method will be applied once that 50% of payments have already been executed using “non-fresh money” currency.
