CORRIGENDA

Chapter “4. DESCRIPTION OF THE INTERVENTION AND METHODOLOGIES OF IMPLEMENTATION”,
Para 4.4 “*Logical framework*”, the first indicator of the Specific Objective of the Call for Proposals
published on 06 July 2021 and related to the aforementioned initiative, is amended as follows:

*“No. of vulnerable people **disaggregated by nationality and gender** (~~% Lebanese and % refugees differentiated by nationality~~) who have increased income thanks to temporary employment opportunities (20% women)”.*

Chapter “4. DESCRIPTION OF THE INTERVENTION AND METHODOLOGIES OF IMPLEMENTATION”,
Para “4.7 Available funds” of the Call for Proposals published on 06 July 2021 and related to the
aforementioned initiative, is amended as follows:

*“An amount not exceeding 60% of the total budget of the project proposal shall be paid as local transfer from a Lebanese bank account to a Lebanese bank account. This modality of execution will be used to execute the payments of the first instalments up to the first 60% of the total amount of the contract. The remaining amount of 40% shall be paid as fresh money in a **Lebanese EU bank account.**”*

Chapter “8. SELECTION, EVALUATION, AND APPROVAL OF PROJECT PROPOSALS”, Para. 14, point 5 of the Call for Proposals published on 06 July 2021 and related to the aforementioned initiative, is amended as follows:

“Capacity to implement economies of scale with resources from other sources, such as to keep the sum of macro-items B, C ~~and E and E-bis~~ of the Financial Plan - Annex A4 - within 25% (item 5.4 of the grid evaluation - Annex A3)”.

Relevant annex A3 *Evaluation Grid Template* has been replaced (see new published annexes).

Para. 5 "Exchange rate" of Annex A10 of the Call for Proposals published on 06 July 2021 and related to the aforementioned initiative, is amended by Art. 4 of Annex *“A8bis. Addendum of the Contract”* as follows:

“All expenses made in currencies other than EUR (euro) must be reported in EUR at the FIFO - First In First Out exchange rate.

The exchange rate applied at the time of the transaction must result from the official documentation issued by the ordering bank, or from the bank statements of the relevant accounts. The implementing entity will be required to enclose the above-mentioned supporting documents to the administrative-accounting report.

Any losses deriving from currency exchange will be borne by the project, with the consequent exemption of the Parties from any further responsibility, while any gains deriving from currency exchange will be allocated to additional activities, subject to a non-onerous variant pursuant to art. 9 of the Contract.” (i.e “Annex A8.
